**INVITATION FOR TENDERS**  
**Contract A1-3 – Procurement of Machinery**

Communal Production Unitary Enterprise “Grodnvodokanal”, hereinafter referred to as “the Purchaser”, intends to use part of the proceeds of the loan from the Nordic Investment Bank (NIB) towards the costs of Contract A1-3 “Procurement of machinery”.

Communal Production Unitary Enterprise “Grodnvodokanal” now invites sealed tenders from eligible tenderers for the contract:

Contract A1-3: The Supply Contract includes supply of one excavator, one bulldozer, and two tipper trucks. As an option the supply may include another excavator and one personnel van. In addition to the machinery, the contract includes commissioning the machinery, training of Purchaser’s personnel, technical maintenance of the equipment during the warranty period, and supply of spare parts for the warranty period.

Delivery time for machinery is 150 days.

Tendering will be conducted through open international procurement procedure (International Competitive Bidding without prequalification) as specified in EBRD’s Procurement Guidelines.

**Eligibility and Qualification Criteria**

Eligible nationalities of tenderers and subcontractors, and eligible origins of goods and related services for Contract A1-3 are specified in Section V of the Tender Dossiers (Eligible Countries).

To be qualified for the award of the Contract, tenderers must satisfy the minimum criteria set in Tender Documents, including but not limited to:

- Tenderer is not bankrupt or under bankruptcy procedures according to the national legislation or regulations;
- Tenderer shall have an average annual turnover as Supplier (defined as billing for Goods and Services delivered or under delivery) over the last three years of not less than 2.0 million EUR equivalent;
- Experience as Supplier in at least three (3) contracts within the last five (5) years, at least one with a value of at least 0.5 million EUR equivalent, successfully and substantially completed and similar to the proposed goods;
- Tenderer must demonstrate access to or availability of financial resources in the amount of not less than 0.5 million EUR;
- Tenderer shall provide evidence that the Tenderer or its agent will be able to carry out the supplier’s maintenance, repair and spare parts stocking and supply obligations.

Tenders must be delivered to the office at the address above on or before 15 August 2018 at 15-00 (local time), after which time they will be opened in the presence of those tenderers' representatives who choose to attend. Electronic tendering and submission of tender by electronic mail will not be permitted.

All tenders must be accompanied by a tender security of EUR 30 000 in a form defined in the Tender Documents.
